Nonetheless it must be recognised that there are risks associated with horseriding and the rider or person with responsibility for another must recognise and acknowledge this risk.

Crindle Stables is located in Northern Ireland. Crindle Stables offers various horseriding experiences. We are located on the Causeway coast, in the beautiful north-west area of Limavady. We are nestled in the Roe Valley area and we are overlooked by the Binevenagh Mountain, an area of outstanding natural beauty. This affords us with lots of opportunities to offer you unique experiences of the great outdoors. Whilst Crindle Stables has taken responsible steps to provide you with the appropriate mount (pre assessment of horse and rider is required on-site prior to Experience). This will ensure you feel comfortable & safe, allowing you to be safe and get maximum enjoyment We will also provide you with the appropriate equipment/ helmet and guides so that you can enjoy an activity for which you may or may not be skilled at. Certain risks cannot be eliminated without destroying the unique character of the activity. The same elements that contribute to this unique character of the activity can be causes of loss or damage to your equipment or accidental injuries. We believe it is important for you to know in advance what to expect and to be informed of the inherent risks. The following describes some but not all of those risks.

Horseback riding can be classified as a RUGGED & RISK ADVENTURE RECREATIONAL SPORTS ACTIVITY And there are numerous obvious and non-obvious inherent risks always present in such an activity despite all safety precautions.

Horses are on average 2 to 10 times larger 10 to 40 times more powerful, and 3 to 4 times faster than a human. If a rider falls from a horse to the ground, it will generally be a distance from 3 1/2 to 5 1/2 feet and the impact may result in injury to the rider. If a horse becomes frightened or provoked it may divert and act according to its natural survival instincts. Which may include but are not limited to stopping short, changing direction or speed at will, shifting a sweet bucking rearing, kicking, biting or running from danger.

We at Crindle Stables try to minimise all risks however it must be recognised that horses can be unpredictable and do have a mind of their own.

Elements along the beaches, trails and road can potentially scare a horse causing it to fall or react in some potential hazardous way some examples: include, bicycles, vehicles, Thunder, lightning, rain, wind, water, wild and domestic animals, insects, and a regular footing on an out of doors groomed or while Taurean. These are subject to constant changes in condition according to weather, temperature, and natural and man-made landscapes. Wearing a helmet whilst riding, being cautious and aware of your surroundings at all times are some basic precautions and certain risks of injuries cannot be avoided if they are not followed.

The undersigned has requested to horseback ride on a unique experience.

The undersigned understands the potential dangers that he or she could incur in mounting or dismounting and in riding a horse. Understanding these risks, the undersigned here by fully and forever discharges and releases Crindle Stables. Its owners, guides, instructors and, employees, agents and volunteers from all liability, claims demands and causes of action, if any, in the event of injury and damage to the undersigned or the property of the undersigned. This release shall be in affect whether such liability, claim, demand, or course course of action is based negligence, gross negligence, recklessness, wilful and wanton conduct, breach of contract brackets expressed or implied) or upon any any other legal theory of any nature whatsoever, and shall be effective regardless of the writing ability of the undersigned.

This release shall be binding upon the undersigned, together with his or heirs, beneficiaries, personal representatives and agents.

If the undersigned is signing this release for a person he is under the age of 18 years, he or she is doing so as a representative of said minor, and will have to designate the representative capacity by circling one of the choices on the signature line and by doing so verifies and acknowledges that he or she has that authority.
